- 1. As the years go by the primary reason for creating and supporting the Lodge becomes lost in the memories of the Charter Members and the archives of the Lodge. A significant impetus for establishing this lodge was to honor a beloved Past Grand Master and his devotion to Masonic education. Therefore we must work to re-instill a sense of purpose with the members and stake holders of the Lodge.
- 2. A characteristic that distinguishes A.D. Smith, Jr. Lodge of Research from other Masonic organizations devoted to providing more light and encouraging scholarly works is our relationship with the M.W. Grand

- Lodge of A.F. & A.M. of the Commonwealth of Virginia. We were chartered by and can be an instrument of the Grand Lodge for the advancement and furtherance of Masonic education in Northern Virginia. I believe we should do everything we can to strengthen this aspect of our existence and become a more important and indispensable tool for implementing the goals and objectives of the Grand Master and the Grand Lodge Committee on Masonic Education.
- 3. The programs and programing of our lodge should appeal to Masons of all stripes: those who have an interest in conducting so-called research themselves, and those who simply thirst for more information and knowledge about Masonry.
- 4. We should encourage a view of our Lodge as an ongoing organization one that functions throughout the year not just on four Saturdays a year to advance its purpose and serve its constituents. The internet, publications and our Speakers Bureau offer distinct possibilities in this regard.
